

# **Campus Conduct and Climate Concerns Assessment**

Below is a breakdown of the types of incidents and concerns related to conduct and climate that were evaluated in the Campus Conduct and Climate Concerns category of the Campus Antisemitism Report Card.

For the 'severe' and 'other' incidents criteria, please note that only incidents that had occurred between April 2024 and December 2024 were counted. For the remaining three criteria in this category, any such activities occurring in 2024 and 2025 were counted.

#### Severe Antisemitic and Anti-Zionist Incidents

The following actions were counted if they included antisemitic/anti-Zionist rhetoric or language:

- Physical assaults
- Death threats or threats of violence (including bomb threats)
- Encampments or building takeovers where antisemitic and anti-Zionist rhetoric or activities were recorded
- Incidents where the offender was a faculty or staff member
- Unauthorized disruption or targeting of events organized by Jewish organizations, such as Hillel, Chabad or Jewish Greek life organizations
- Targeted harassment
- Vandalism, graffiti and destruction of property
- Arson or attempted arson
- University disinviting Jewish, Zionist and/or Israeli speakers due to their identity/national origin
- Guest speakers organized by staff/faculty members and/or administrators
- Events organized by staff/faculty members and/or administrators
- Panels, lectures and listening series organized by staff/faculty members and/or administrators
- Workshops and trainings organized by staff/faculty members and/or administrators

#### **Other Antisemitic and Anti-Zionist Incidents**

The following actions were counted if they included antisemitic/anti-Zionist rhetoric or language:

- Verbal abuse
- Graffiti that does not result in destruction of property (e.g., chalkings)
- Defacement of flyers or posters
- Offensive literature distribution

- Protests
- Guest speakers organized by students
- Events organized by students
- Panels, lectures and listening series organized by students
- Workshops and trainings organized by students

### Hostile Antisemitic and Anti-Zionist Student Government Activity

- The student government voting in favor of a pro-BDS resolution
- The student government withholding funds from other student groups to pressure administrators to accept their demands in furtherance of BDS objectives
- The student government releasing a statement in support of BDS or denouncing the existence of the State of Israel
- The student government refusing to recognize Jewish student organizations

## Presence of Hostile Antisemitic and Anti-Zionist Student Group Activity

- Promotion of antisemitic and anti-Zionist rhetoric through on-campus, off-campus or online activities (e.g., protests, petitions, events and publications)
- The targeted harassment of Jewish organizations or Jewish members of the campus community with antisemitic rhetoric
- Promotion of anti-Israel divestment/the BDS movement
- Organized disruptions of events organized by Jewish and/or Israeli organizations and/or groups

## Presence of Hostile Antisemitic and Anti-Zionist Faculty Group Activity

- Engaging in antisemitic and/or anti-Zionist rhetoric in the classroom or through campus publications
- Cancelling or re-scheduling classes to attend anti-Israel protests
- Assigning extra credit or providing academic incentives to encourage students to attend anti-Israel protests
- Promotion of the BDS movement
- Promotion of antisemitic and anti-Zionist rhetoric through on-campus, off-campus or online activities (e.g., protests, petitions, events and publications)
- The targeted harassment of Jewish organizations or Jewish members of the campus community
- Organized disruptions of events organized by Jewish and/or Israeli organizations and/or groups with antisemitic rhetoric
- Presence of an FJP chapter
